Anti-Ragging Affidavit (Mandatory for all students)

1. It has been made mandatory by the AICTE and by the Hon'ble Supreme court that each student is to provide an affidavit on a Non-Judicial Stamp Paper of Rs.10/- duly attested by oath commissioner (in the notary in their own Home-town) to the effect that he would not indulge in any ragging activities (Format 1). It has also been made mandatory for the parents to give a similar affidavit on a Non Judicial Stamp Paper of Rs.10/- duly attested by oath commissioner saying that their wards would not indulge in any such ragging activities (Format 2). Separate formats have been designed for both students and parents.

Students and parents are advised to read carefully the Regulations of All India Council of Technical Education (AICTE) which was notified vide F.No. 37-3/Legal/AICTE/2009 dated 01 July 2009 and is available on <http://www.aicte-india.org/anti.htm> and submit the affidavits in original to the **Admission Desk**.
4. The Affidavits of both the students and parents are to be submitted together to the **Admission Desk**. Single Affidavit of either the student or the parents will not be accepted.
